#### Additional Comments:

Tree 2 was in fair health and condition. Some borer damage was evident. Recommendations are made to prune the canopy by 15% reduce end weights, remove the epicormic growth and deadwood. Further more, it is recommended the trees be monitored for its health and condition.

The following trees located in the Garden Bed outside the Phyllis Stewart Building can be also removed due to being considered exempt from Councils 'Preservation of trees' provisions due to their height, species or can be removed due their condition.

Brachychiton acerifolius -Flame Tree (T17) exempt species

Pittosporum sp. Less than 5 metres

Eleaocarpus reticulatus -Bluberry Ash (T18) - 5 metres height criteria

Eucalyptus haemastoma (Scribbly Gum) Smaller Tree with decayed trunk leaning over car park
