Construction Notes

1. Construct sediment fence as close as possible to parallel to the contours of the site.

2. Drive 1.5 metre long star pickets into ground, 3 metres apart,

3. Dig a 150 mm deep trench along the upslope line of the fence for the bottom of the fabric to be entrenched.

4. Backfill trench over base of fabric.

5. Fix self-supporting geotextile to upslope side of posts with wire ties or as recommended by geotextile manufacturer.

6. Join sections of fabric at a support post with a 150 mm overlap.






