Development Application No. DA2019/0719 for Regularisation of existing signage (Business Identification Signs) at 20-22 Macpherson Street Warriewood

Council has completed a preliminary assessment of your application which was received by Council on 05/07/2019 and has identified a number of areas of non-compliance and insufficient information that will not allow Council to support the application in its current form.

These matters are as follows:

Environmental Planning and Assessment Act 1979

cl. 4.2 Development that needs consent: The signage is already been constructed and therefore development consent cannot be granted retrospectively.

Environmental Planning and Assessment Regulation 2000 (EPA Reg) - Owners Consent

cl. 49(1) Persons who can make development applications: Owners consent has not been provided to make the application.

State Environmental Planning Policy (SEPP) 64 - Advertising and Signage

The signage does not comply with the objectives of SEPP 64 in terms of the following Schedule 1 Assessment criteria;

- a) 1. Character of the area
- b) 4. Streetscape, setting or landscape
- c) 5. Site and building
- d) 8. Safety

Pittwater 21 Development Control Plan

cl. C5.9 Signage: The freestanding signage is not compatible with the desired amenity and visual character of the locality. Further, the area of each sign exceeds the minimum 4.5sqm requirement of the control.

Please accept Council's sincere apologies for the delay in this correspondence.



Unfortunately, due to the extent of the issues outlined in this correspondence, Council is unable to support the proposal in its current form.

You are therefore strongly encouraged to withdraw this application and resubmit a new application that addresses all of the issues listed above.
