(a) Condition 27 be modified to read as follows:

27. The stated level of use by the Manly-Warringah Rugby League Club during the season other than preseason, practise or exhibition matches, is generally:

Weekly Training Monday, Tuesday & Thursday evening –

from 16:30 to 22:00

Wednesday evening training -

from 16:30 to 20:30

Saturday and Sunday morning –

from 07:00 to 10:00

National Competition Matches 12 home matches to be played in the Season

The matches may be scheduled on: Friday evening – finishes at 22:00 Saturday afternoon – finishes at 18:00 Saturday evening – finishes at 22:00 Sunday afternoon – finishes at 18:00

One (1) Monday evening (21 May 2007) -

finishes at 21:00

(b) Condition 28 be modified to read as follows:

"28. Night matches are limited to 12 matches per season to be played on either Friday, Saturday nights and one Monday night game on 21 May 2007."

(c) Condition 58 to be amended to read as follows:

"58. Implementation of Operational Plan of Management for Monday night Game

The lessee is to undertake appropriate actions as required by the Operational Plan of Management 'Proposed Monday night Football Management Plan for 21st May 2007' for the Monday night game as approved in the modification of Condition 28.

(Note: Failure to implement this Plan of Management is a breach of this consent.)

In addition to the requirements of the Operational Plan of Management 'Proposed Monday night Football Management Plan for 21st May 2007' a hotline shall be available for residents to call for the full duration of the match, including 1 hour before and 1 hour after the match. The purpose of the hotline is for an operator to receive calls relating to issues resulting on game night and coordinate immediate action to such issues. The operator must have direct contact to the ground announcer and the security coordinator/supervisor on the night. The hotline number should be publicly distributed to local residents a minimum 3 days before the match.

Reason: To reduce impact on surrounding residential areas"

This letter should therefore be read in conjunction with Development Consent 94/380 dated 22 August 1994 and Modification Consent 6000/4021/02 dated 13 March 2007.
