1. Summary

This report outlines the outcomes of community and stakeholder engagement on a proposed trial to support conservation of the threatened Eastern Osprey (*Pandion cristatus*) through the provision of a specialised nesting platform at Careel Bay playing fields near Hitchcock Park, Avalon Beach.

The draft proposal was exhibited for 28 days during May-June 2024. Feedback received was overwhelmingly positive, with a majority of responses indicating a high or very high level of support. Some respondents, while supportive of the intention to improve habitat for ospreys, raised concerns regarding the suitability of the proposed location and potential impacts to the birds.

A high proportion of the submissions also indicated strong support for additional osprey nesting platforms across the LGA, with suggested locations including sports fields, surf clubs and beaches. Several submissions also highlighted the benefits of installing cameras and educational signage to promote awareness of ospreys and their conservation.

Of the respondents who were not supportive of the proposal, many felt that Council budget should be spent elsewhere. Other submissions raised concerns about the lack of suitable natural nesting habitat (i.e. tall trees) within the LGA.



2. Background

The Eastern Osprey (*Pandion cristatus*) is a threatened native bird of prey which occurs within coastal areas across eastern Australia. Ospreys typically build their nests in tall trees close to aquatic environments; however, in recent years there have been several instances where pairs have established nests on human-made structures such as sports lighting and construction cranes. This has the potential to disrupt osprey breeding cycles and create challenges for development projects when cranes need to be dismantled and removed from site.

To address this potential risk, we propose to take the lead and be the first Sydney council to install a specialised nesting platform for ospreys. Ospreys have successfully taken up artificial nesting platforms at numerous other locations in northern NSW, south-east Queensland and South Australia. It is anticipated that learnings from the trial will contribute to future similar projects elsewhere within the LGA and the broader Sydney region.

The project has received generous support from the NSW National Parks and Wildlife Service (NPWS) and the Biodiversity, Conservation and Science division of the NSW Department of Climate Change, Energy, the Environment and Water (DCCEEW).

An environmental assessment has been undertaken in accordance with Part 5 of the Environmental Planning & Assessment Act 1979 (EP&A Act), and is available upon request.

The draft proposal was exhibited on Council's Your Say page for 28 days during May-June 2024. Nearby residents and key stakeholders were contacted directly and, along with the broader community, encouraged to provide feedback on the proposed location and design.

The accumulated responses are collated and synthesised in this comprehensive report. The feedback received will be used to inform and refine the final project design.

3. Engagement objectives

Community and stakeholder engagement aimed to:

- liaise with local residents, as well as start a conversation with the Resident Association on the pilot project to integrate relevant community feedback during implementation
- build wider community and stakeholder awareness of engagement activities regarding the pilot project
- provide accessible information so community and stakeholders can participate in a meaningful way
- identify community and stakeholder concerns and test the appetite of future locations should the pilot be a success; and
- manage community and stakeholder expectations of the project, including the duration of the pilot project.

4. Engagement approach

Community and stakeholder engagement was conducted between 29 May and 26 June 2024 and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Strategy (2022). A project page³ was established on our Your Say platform with information provided in an accessible and easy to read format. The consultation was pitched at qualitative engagement only.

The project was primarily promoted through our regular email newsletter (EDM) channels, Facebook, on-site signage and a letter mailout. Emails were also sent to the Avalon Preservation Society, relevant sporting user groups, environment groups, wildlife carers and Birdlife Australia. Community members were offered a 'book a chat with the project team' as part of the consultation process and a presentation was also given the Environment Strategic Reference Group (ESRG).

Feedback was captured through an online comment form embedded onto the Your Say project page. The open-field comments box provided community members a space to share what they liked most about the proposal, as well as any concerns or suggested improvements.

Email and written comments were also invited in the interest of inclusivity.

Community and Stakeholder Engagement Report Osprey nesting platform, Avalon Beach

A thorough stakeholder mapping exercise was completed to identify and understand the stakeholders and a Community and Stakeholder Engagement Plan was developed.

It was determined for this project that it was particularly important to hear from local residents, sporting groups which use the playing fields, environmental groups and the youth.

In addition to regular channels and engagement techniques to capture a range of views, we also advertised the exhibition and Your Say landing page in our youth newsletter, and targeted potential stakeholders through social media.

5. Findings

A total of 164 submissions were received, with approximately 95% in support of the proposal. Most of the respondents provided full support for the proposal in its current design and location. Many identified the need for additional habitat for threatened species in the locality and responded favourably to Council taking the lead in such an initiative.

Some respondents noted personal anecdotes of witnessing ospreys nesting on artificial structures including cranes and light poles at sporting grounds, highlighting a high level of community awareness of and concern for the welfare of our local ospreys.

A small percentage of submissions were in general support, however raised concerns relating to the proposed location, particularly around the potential for impacts to the ospreys from disturbances such as off-leash dogs, light pollution, lightning strikes and human interference.

Only a handful of submissions were not supportive of the proposal, mostly due to the perceived cost to rate payers.

Will the ospreys be impacted by:	Ospreys in the Northern Beaches LGA are commonly nesting on artificial structures such as cranes and sports lights. A number of currently active nests are located within sports fields which have bright lighting, high levels of human traffic and dogs (both off-leash and onleash). The sandflats at Careel Bay are not part of the proposed project area, however compliance officers do patrol all of Council's parks and reserves and will continue to do so, issuing fines where required.
Can the nesting platform be installed on an existing pole?	This was investigated and considered not viable due to safety reasons including weight limitations on the existing poles which may not support an additional structure.

How is the effectiveness of this structure to be assessed? What is the timeline for the assessment, who will be doing the assessment and who will the assessment be given to?	The effectiveness of the nesting platform will ultimately be dependent on ospreys nesting successfully on the platform. The timeline for this project is 5 years and will be undertaken by Council's Biodiversity Team in conjunction with key State agencies.



Question raised in feedback	Council's answer
If the structure fails to attract any nesting ospreys, will the structure be removed?	If there have been no nesting attempts by ospreys within 5 years of installation of the platform, we will consider removal and/or relocation of the structure.
Will more nesting platforms be installed within the LGA?	Council is committed to the conservation of threatened species habitat. This project is intended as a medium to long term trial and data will be collected to ascertain the success of the platform. We are hopeful that the trial will be successful and that its outcomes can be replicated across the LGA and broader region, as required and subject to funding.
Can it be designed to look a little more tree-like/made from wood or natural materials? Possibility to have a few different sizes in the same quadrant to make them look like a public artwork?	The proposed design is an aluminium basket on top of a timber pole which will minimise weight and improve resistance to wind loading. Aluminium also allows better ventilation to the nest and ease of cleaning and maintenance, if required. This design is based on best practice methodology which has proven successful across QLD, SA and northern NSW. We have consulted with experts on osprey habitat requirements and behaviour and it is not favourable for ospreys to have numerous nests in close proximity to one another.
Can Council reduce tree removals on public and private land to retain potential breeding habitat for Ospreys as an alternative to the nesting platform?	The proposal aims to address ospreys nesting on artificial structures by providing a dedicated and safe space for them to nest. While tree preservation is outside the scope of this project, Council is committed to retaining and enhancing our local tree canopy, as evidenced by our Tree Canopy Plan which sets a target to plant 5,000 trees per year for 20 years.
Would Council consider installation of waterway and shore signage to educate the community on the dangers of discarded fishing tackle?	Signage is proposed as part of the project to raise community education and awareness. Potential impacts to ospreys such as fishing gear entanglement is proposed to be highlighted as part of this signage.



Question raised in feedback	Council's answer
Is there consideration for legally insisting on viable corridors as part of urban expansion? Lizard Rock area is a very strong example.	Whilst this is outside the scope of the project, Council has a strong commitment to protecting wildlife corridors and tree canopy, as demonstrated by our Tree Canopy Plan 2023 and the Northern Beaches Environment and Climate Change Strategy 2040. Existing planning controls are in place to protect wildlife corridors and will be further consolidated as part of the new Northern Beaches LEP/DCP.
