Re: DA2025/0132 - Demolition works and construction of a restaurant (McDonalds) including signage

Dear Sir/Madam,

I wish to submit a submission **against** the development application DA2025/0132.

Points of concern:

 My family and I live across the road from the proposed site at 76 Kenneth Road. We will be directly affected by this development in many ways - noise, odour, litter, vermin, anti-social behaviour, a potential increase in crime and traffic. I've also been advised that our property will de-value, affecting our financial stability. Local realtors have verbally quoted decreases in value to our property, as well as others in our apartment block, of between 5 and 24 percent.

<u>Traffic</u>

- The roundabout at Kenneth Road and Roseberry Street is already a point of congestion. This is mainly due to the traffic flow from the traffic lights at the intersection of Kenneth Road and Condamine Street. The green arrow to turn right onto Condamine Street from Kenneth Road only allows a few cars through at a time. This causes traffic to back up at various times during the day - every day of the week.
- I note that the traffic survey completed as part of the DA did not include peak hour traffic in the morning or anything for Sunday. The analysis in the survey in point 2.12 on page 7 states

"o the signalised intersection of Condamine Street and Kenneth Road is operating with average delays of less than 40 seconds per vehicle during weekday afternoon and Saturday midday peak hours. This represents level of service *C*, a satisfactory level of service;

o the roundabout controlled intersection of Kenneth Road and Roseberry Street is operating with average delays for the highest delayed approach (Roseberry Street south) of less than 30 seconds per vehicle during weekday afternoon and Saturday midday peak hours. This represents level of service B/C, a satisfactory level of service; "

I refute this assessment as this is not representative of the traffic conditions and the results are completely inadequate.

A Media Release from the Council on 28th November, 2018 (attached separately) titled *Options to end traffic congestion in Manly Vale/Balgowlah* acknowledged the traffic congestion in the area and that is would worsen with the arrival of Aldi on Roseberry Street. Ideas to improve the traffic included, amongst others, major recommended changes such as opening the dead end at Quirk Road and new traffic control signal requirements. This is yet to happen and Aldi has been open for a while now.

• Residents are yet to move into the new apartments at the southern western corner of the intersection of Kenneth Road and Condamine Street. The neighbourhood is yet to feel the effects of the additional residents on the traffic in the area.

<u>Noise</u>

• We already contend with noise from traffic and late night revellers on Kenneth Road. A 24 hour fast food outlet will only contribute to this. We're concerned of anti-social behaviour and unwanted late night activity around the clock across the street from where we live.

<u>Plans</u>

The plans provided in the DA showed the following that will produce noise and light pollution that will affect us directly as we will face the northern elevation.



1 NORTH ELEVATION (STREET FRONT)

On the northern boundary there will be some tress, timber fencing and shrubbery along Kenneth Road - this will not suppress any sound from the franchise. The proposed drive thru will be running along the Kenneth Road side of the property, allowing for 6 vehicles and 3 windows - all of which will produce noise from headsets, customers and cars.



KENNETH ROAD

There is also a "playplace" inside the proposed franchise which will also produce the noise of screaming children day and night.

The proposed lighting includes a 7m tall "blade" and a 9m pylon both of which will be alight through the night and are both eyesores.





Existing Franchises



The distance from 37 Roseberry Street to other franchises: Warringah Mall - Condamine Street = 3km Brookvale - 6 Mitchell Road = 3.4km Beacon Hill - 164 Warringah Road = 4.8km Forest Way - 22 Forest Way = 8km

KFC - 273 Condamine Street = 250m

There are 3 local McDonalds franchises within 5km of the proposed site not as well as a KFC 250m away on Condamine Street. Personally, I don't think we need another fast food outlet so close to already existing ones - it's excessive and unnecessary.

In conclusion, this proposal is totally inappropriate for the location and its surrounds. Please see an email below from the office of James Griffin MP who agrees this it not the correct site for a McDonalds restaurant.



Dear Sarah

Thank you for writing to James Griffin MP outlining your concerns with this Development Application which you might be aware has now been referred to the Independent Planning Panel.

Mr Griffin has asked me to let you know he believes that this site is not the correct location for a McDonalds fast food restaurant. Noise, traffic, litter and everything that a 24hr venue brings to a residential area are all reasons for McDonalds to find a different location. There are far more appropriate locations.

Mr Griffin has said that "Most McDonalds are built on main roads; Roseberry Street is not a main road and is opposite residential properties".

If you have not done so, Mr Griffin encourages you to lodge your submission to the Council.
