This is to confirm our telephone conversation of this morning, & that you will still accept my submission in respect of the above Proposed Development Modification. I wish to object to the proposed extension of the work hours (to 8pm Mon to Fri & to 4 pm on Saturday), to the Harbord Diggers Development.

I have read the document from the developers, however, I consider that it is a bridge too far to expect the good neighbours of Evans Street, to be subjected to further inconvenience, as a result of the Diggers' project. At the outset of this project the good neighbours were invited to the club for consultation & it was expressed that as little disruption as possible would occur. This project has been granted by Council, with the normal working hours afforded to similar projects.

There are several families living in the Evans Street apartments across from the project, and the inconveniences already experienced have been considerable. It is my contention, that rather than extending the working hours, that the contractors, could be asked to consider simply hiring more tradespersons, to accomplish what they would in the normal working day (as already approved by Council), instead of extending the workers, 'working' hours. As well, if this work is internal (as outlined), than there would be no wet weather delays to consider. Accordingly, I am objecting to this s96 amendment.
