Hi Maxwell,

I would like to submit the following in relation to DA2021/2559

- During construction
 - We are a disability service located next door to the proposed DA (26 William Street, Brookvale). We support adults with intellectual and multiple disabilities 7 days per week. We have a 2nd centre at 2 Grosvenor Place and during the day we have groups that travel by foot between the 2 centres by foot multiple times per day. Our usual route sees our groups crossing the driveway of 8 Grosvenor Place, Brookvale to walk further into the cul-de-sac of Grosvenor Place where it is safer to cross the road. During construction we would need to be able to continue to safely pass the driveway of 8 Grosvenor Place, Brookvale.
 - Many of our service users have diagnosis that require support to manage noise levels and changes to their environment. While we understand that heightened noise levels and environmental changes may occur during construction, it would be very helpful to our service users and support staff if we could be kept informed of the progress and what to expect.
- After construction
 - As we would continue using the footpath and crossing the driveway we would request that consideration is given to maintaining a high level of visibility for both pedestrians and vehicles in and around the entry/driveway.
