49 Frenchs Forest Road, Frenchs Forest Forest Central Business Park - Private Road Proposal for Pedestrian Protective Railings

The information attached to this letter is in relation to a current proposal to install protective railings down either side of the existing private road within Frenchs Forest Business Park to separate the pedestrian path from the private road and prevent cars from parking on the pedestrian path.

The proposal has been on the agenda of the business park, due to existing parking and pedestrian issues within the business park, but was postponed until the completion of the RMS works, including the installation of traffic lights from Forest Central Business Park onto Frenchs Forest Road and new pedestrian footpaths to either side of the entry to the Forest Central Business Park. Now the RMS works, traffic lights and the new entry footpaths are completed, it is proposed to proceed with the installation of the protective rails to the pedestrian footpath.

The proposed installation of the protective railings, in the locations marked red on the attached Forest Central Business Park site plan, has been quoted by multiple contractors and is currently being collated for presentation to the committee of the Forest Central Business Park to complete this previously identified issue in the New Year.


The proposal seeks to provide a safe pedestrian walkway on the originally constructed footpath on both sides of the driveway as well as prevent the current illegal parking on the footpath and along the private road. This will ensure that the driveway remains trafficable and visibility is maintained for vehicles entering and exiting all buildings from the private road, and formalises safe passage for pedestrians to transit through the business park.






