Also a major concern on these days is Safety, our neighborhood consists of many families with young kids, you can imagine the issues would be multiplied with bumper to bumper parking most nights due to lights.

My suggestion is that a Car Park be created, we already have one at Freshwater Campus that is rarely utilized. Also in front of Freshwater Campus there is a field that has many bumps, hills, valley and ditches making it an unsafe playing field – extend that into the car park. And maybe convert Halloway Place, Manuela Place and Bennett Street into restricted parking Zones to force usage of Car Park.
