I would like to object to the extension of work hours.

Currently I am woken most days from between 0500-0600.

This is due to the following:

- 1. builders having loud conversations and yelling at each other from the scaffolding into the building site.
- 2 Engine breaking and usage of the horn from trucks waiting to get into howard ave or oaks
- 3. Trucks (dirt, concrete, crane or building materials) arriving at 0600 and sometimes earlier waiting for the site to begin work.

Once the work goes ahead and the scaffolding gets even higher then the noise of the tools and workers will be even greater. I am already at a stage where I am unable to open the sliding doors to my balcony due the noise and dust on afternoons when I get back from work on most of Saturday when the site is active.

Between the noise and dust from the site my outside area which equates to 50% of my units area is almost unusable.

I can only image that this when taken into account with the construction on corner of pittwater and st davies rd will make this whole corner a very unpleasant place to live for quiet some time.

It feels as though council has not given the developments and its impact on the Dee Why residents much though.
