1. Introduction

Certified Energy has been commissioned to prepare an Energy Efficiency Report for the proposed development at 4 Brookvale Avenue Brookvale NSW. The development is comprised of multi-unit development. The aim of this report is to determine the appropriate Energy Efficiency provisions that this project must adopt to comply with the increased BASIX energy target commitments in NSW.

2. Methodology

Thermal Modelling was undertaken on each of the dwellings using Bers PRO v4.3 to assess the Heating and Cooling loads that are required to maintain an appropriate level of Thermal Comfort within each dwelling. These loads combine to produce a NatHERS energy star rating for each dwelling. Each dwelling must comply with maximum individual heating and cooling target caps as specified in the recently updated (1st July 2017) NSW BASIX Thermal Comfort Protocol. This report specifies the required amounts of insulation (R Values) and window performance (U Values) required for each dwelling to comply with these updated targets. *(refer development specification sheet)* 3.
