The proposed modification includes changes as follows:

- Changes to windows and doors
- Deletion of approved first floor vergola
- Deletion of Condition requiring a privacy screen to the first floor terrace

<b>Detailed Site Description:</b>	<p>The subject site consists of one allotment located on the northern side of Wyadra Avenue.</p> <p>The site is regular in shape with a frontage of 13.41m along Wyadra Avenue and a depth of 36.565m. The site has a surveyed area of 490.3m<sup>2</sup>.</p> <p>The site is located within the R2 Low Density Residential zone and accommodates an existing dwelling house.</p> <p>The site is generally flat.</p> <p>The site contains small planted vegetation in addition to two significant trees in the front yard.</p> <p><b>Detailed Description of Adjoining/Surrounding Development</b></p> <p>Adjoining and surrounding development is characterised by dwelling houses, dual occupancies and residential flat buildings.</p>

## **State Environmental Planning Policies (SEPPs) and State Regional Environmental Plans (SREPs)**

### **SEPP 55 - Remediation of Land**

Clause 7 (1) (a) of SEPP 55 requires the Consent Authority to consider whether land is contaminated. Council records indicate that the subject site has been used for residential purposes for a significant period of time with no prior land uses. In this regard it is considered that the site poses no risk of contamination and therefore, no further consideration is required under Clause 7 (1) (b) and (c) of SEPP 55 and the land is considered to be suitable for the residential land use.

### **SEPP (Building Sustainability Index: BASIX) 2004**

A BASIX certificate has been submitted with the application (see Certificate No. A355022\_02 dated 21 April 2020).

### **SEPP (Infrastructure) 2007**

### Ausgrid

#### **D8 Privacy**

##### Merit consideration

The proposed changes to windows/doors are to the ground floor rear and western side facade, and are sufficiently set back from the property boundaries. The modification includes the deletion of the approved vergola to the first floor terrace. As there are no remaining works proposed to the terrace, Condition 10 requiring a privacy screen may be deleted.


