MID FLOOR PLAN

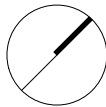

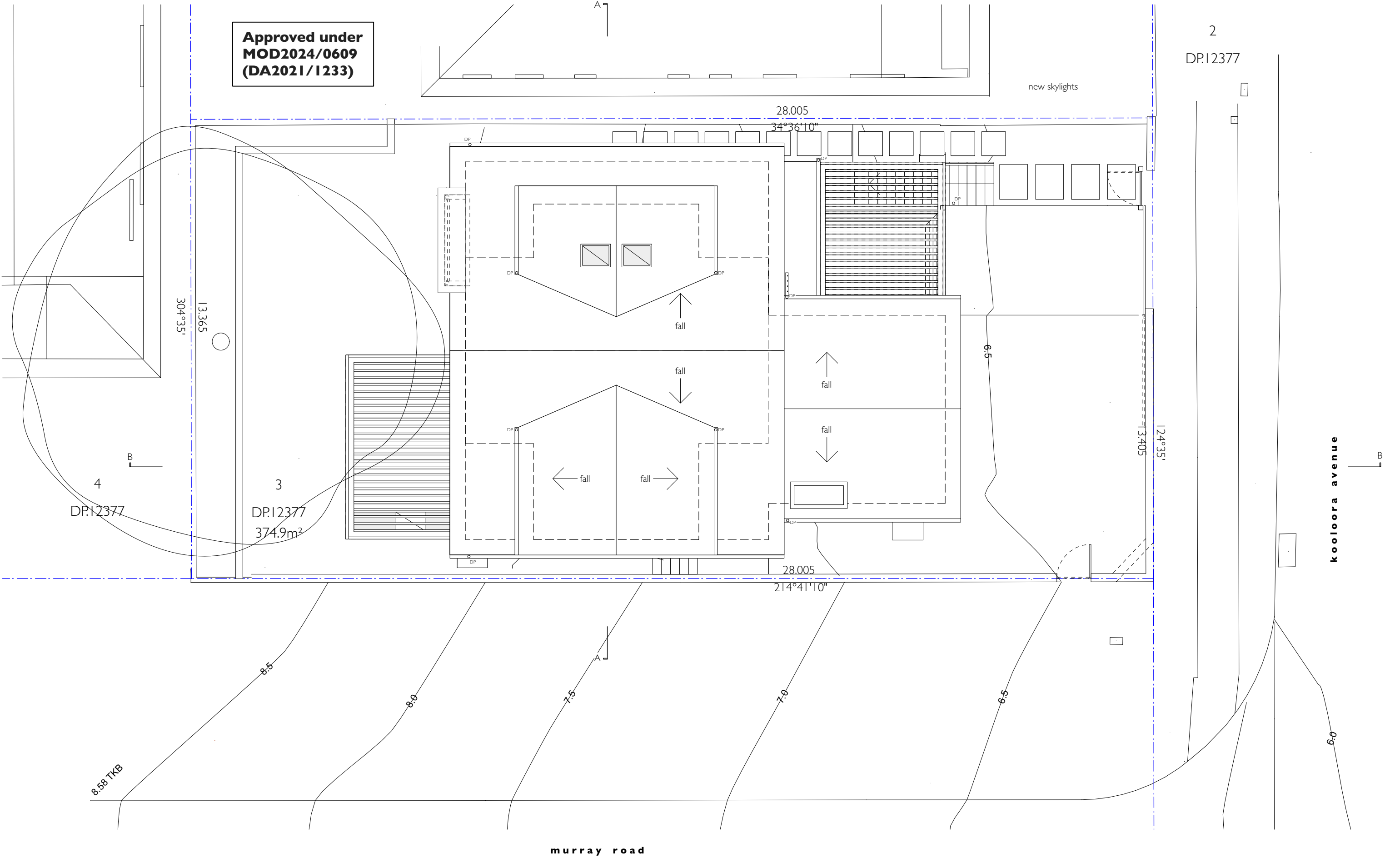

UPPER FLOOR PLAN

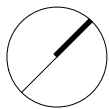
