Toughened glass	Fire Engineering Report No. S17137 Rev 1.3 prepared by MCD dated 20 April 2020: The type of glass shall be toughened safety glass. The thickness of the pane of glass shall be at least 6 mm thick. Window frames and hardware shall be made of metal (aluminium allowed). Seals to stiles, head and sills or thresholds shall be manufactured from silicone (having a flammability index no greater than 5 according to AS 1530.2). A fixed tag shall be placed on the inside of the window framing and toughened glazing. Refer to construction certificate when replacing the window.
