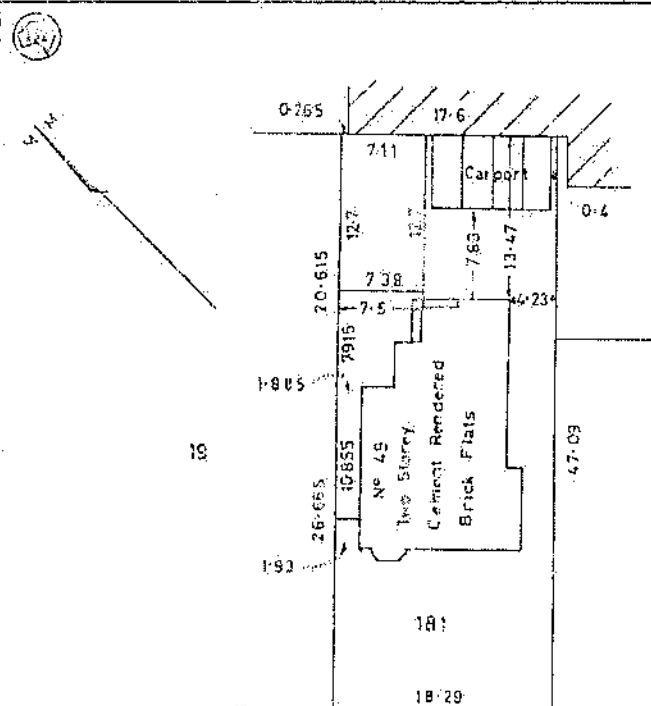

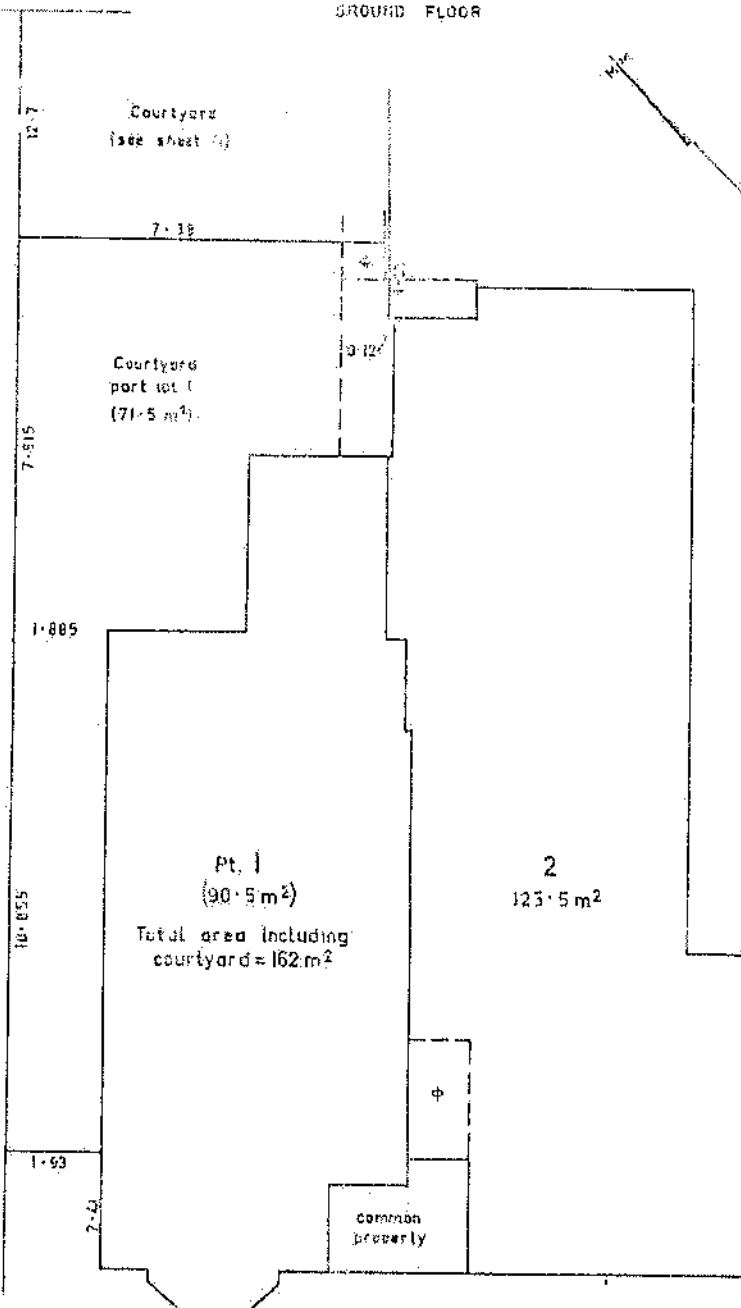

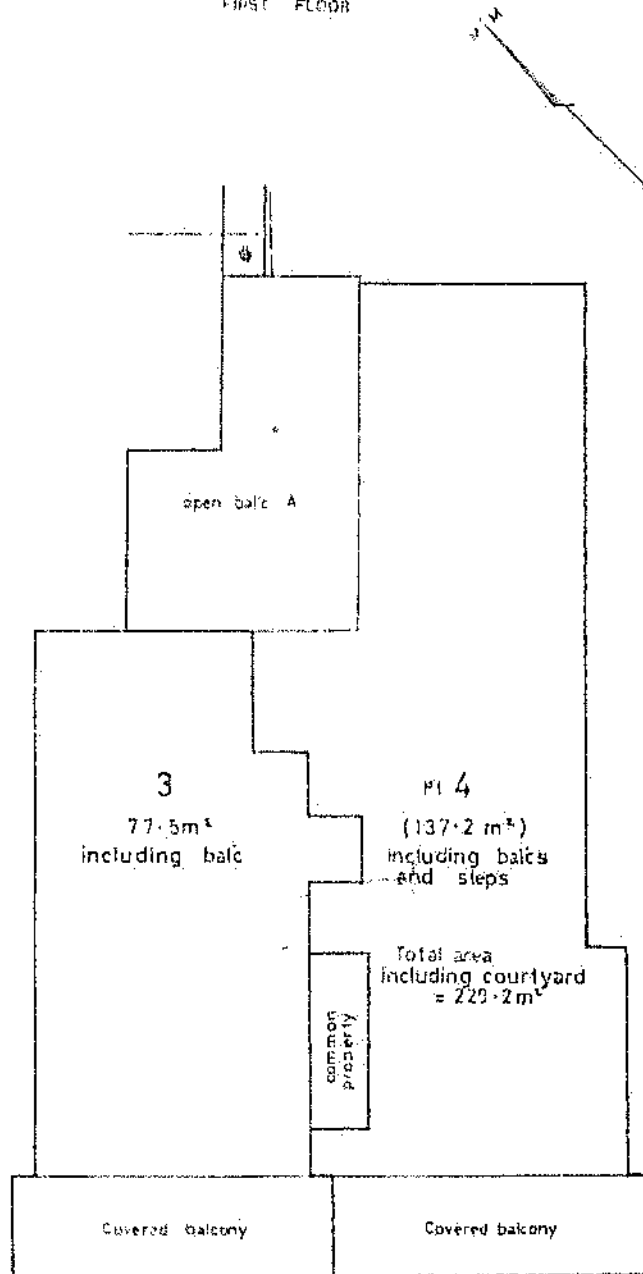

Steps (part lot 4) are limited in height from the underside of these steps to the upper level of balcony A.

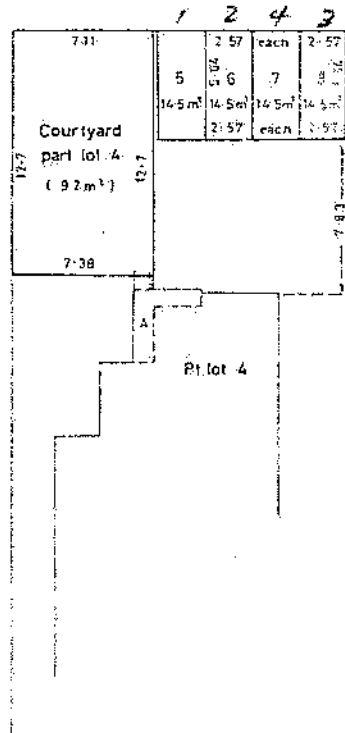
