### **Building Code of Australia Report**

The Building Code of Australia recommendations contained in the "Capability Statement for DA" prepared by Technical Inner Sight, dated 05/12/2023, Report Ref No.d2023 - 054 are to be considered as part of the assessment of the Construction Certificate.

Details demonstrating compliance are to be provided to the Certifying Authority prior to the issue of the Construction Certificate.

**Reason:** To ensure adequate provision is made for Health, Amenity, access and Fire safety for building occupant health and safety.

### National Construction Code (BCA) Access upgrades Access and Facilities for Persons with a Disability

Access and facilities to and within the building are to be provided for Persons with a Disability and are to comply with the Building Code of Australia and AS 1428.1.

In this regard the Access Report prepared by "Code Performance", reference no. 21026 - R1.3, dated 06/12/2023 is to be considered as part of the assessment of the Construction Certificate. Details are to be provided to the Certifying Authority prior to the issue of the Construction Certificate and be implemented prior to occupation of the building.

**Reason:** To ensure adequate provision is made for access to and within the building for Persons with a disability.
