Reasons for referral

This application seeks consent development on land, or within 40m of land, containing:

- All Development Applications on
- Actual or potential threatened species, populations, ecological communities, or their habitats;
- Wildlife corridors;
- Vegetation query stipulating that a Flora and Fauna Assessment is required;
- Vegetation query X type located in both A & C Wards;

And as such, Council's Natural Environment Unit officers are required to consider the likely potential environmental impacts.

Officer comments

Updated Biodiversity Referral 30/05/2002

The amended Landscape Plan by Spirit Level Designs (24/05/22) and the additional Arboricultural Impact Assessment information by Tree Survey Arboricultural Consultants (23/05/22) are supported. Concerns raised in the previous biodiversity and landscape referral are considered addressed.

The proposal identifies the removal of two trees which are not considered of biodiversity value.

However, as identified in Council's landscape referral, further information is required to clarify or confirm potential impacts on select trees which are part of the Pittwater Spotted Gum Threatened Ecological Community (TEC). Where tree removal or impacts are subsequently proposed, further assessment and reporting will be required. Council's biodiversity team recommend avoiding and minimising impacts to all existing Spotted Gums including by way of redesign where necessary. Where tree removal is proposed, assessment of impacts to the TEC under Section 7.3 of the NSW Biodiversity Conservation Act 2016 will be required. The assessment must be completed by a suitably qualified ecological consultant. Landscaping should also including greater provision of local native species as required by Pittwater DCP, clause B4.7.

The proposal is therefore supported.
