Discussion of reason for referral

This application has been referred as it is a listed heritage item, being *Item 176 - "Freshwater" Restaurant, 80 Undercliff Road, Freshwater*, listed in Schedule 5 of WLEP 2011.

Details of heritage items affected

Details of this heritage item, as contained within the heritage inventory, are:

Item I76 - "Freshwater" Restaurant, 80 Undercliff Road, Freshwater

Statement of Significance

A building with great social & historical significance as an early meeting place & recreation venue for the first settlers in Freshwater. Representative of the federation style, with high integrity. Prominent local landmark located above Freshwater Beach.

Physical Description

Two storey building of residential form. Timber weatherboard walls and tiled multi-gabled roof. Gables contain a variety of detail from timber shingles & timber battened trim to a variety of window types. Wide segmented verandah, infilled with glazing.

Consideration of Application		

Updated Comments - 24 August 2023

This application seeks to formalise use of the site for events ancillary to the restaurant and also seeks approval for unapproved structures, namely the "Pilu Pavilion" and the "Wedding Ceremony Umbrella" located within the garden area of the existing heritage building. The application also proposes to update the restaurants operating hours.

These structures are used for weddings and other events and are located to the east of the main heritage building, within the garden setting. The application states that these structures were in



existence (without consent) when Pilu began operating from the site in 2004. No physical works are proposed as part of this application.

As this application is seeking approval for structures within the curtilage of a heritage building, which have never been approved, it was considered that the application should have included an assessment of the impact of these existing structures on the heritage significance of the item. This Heritage Impact Statement (HIS) was requested on 1 May 2023 and has now been submitted.

The submitted HIS, prepared by Urbis dated 16 May 2023 has been reviewed. The report concludes that the two structures, "Pilu Pavilion" and the "Wedding Ceremony Umbrella", have no adverse impact upon the heritage significance of the heritage item and their continued use will ensure that the heritage building maintains its contribution as a meeting place and restaurant into the future.

These conclusions are agreed with. The structures are lightweight and easily reversible should they be not needed in the future. They do not attach to any original fabric and are low scale in nature, thereby not interfering with views to or from the heritage building. Therefore, the impact of these structures within the curtilage of the heritage building, is considered acceptable.

Therefore, no objections are raised on heritage grounds and no conditions required.
