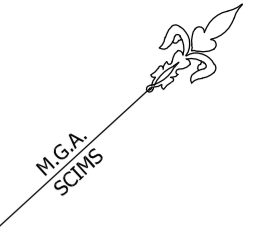

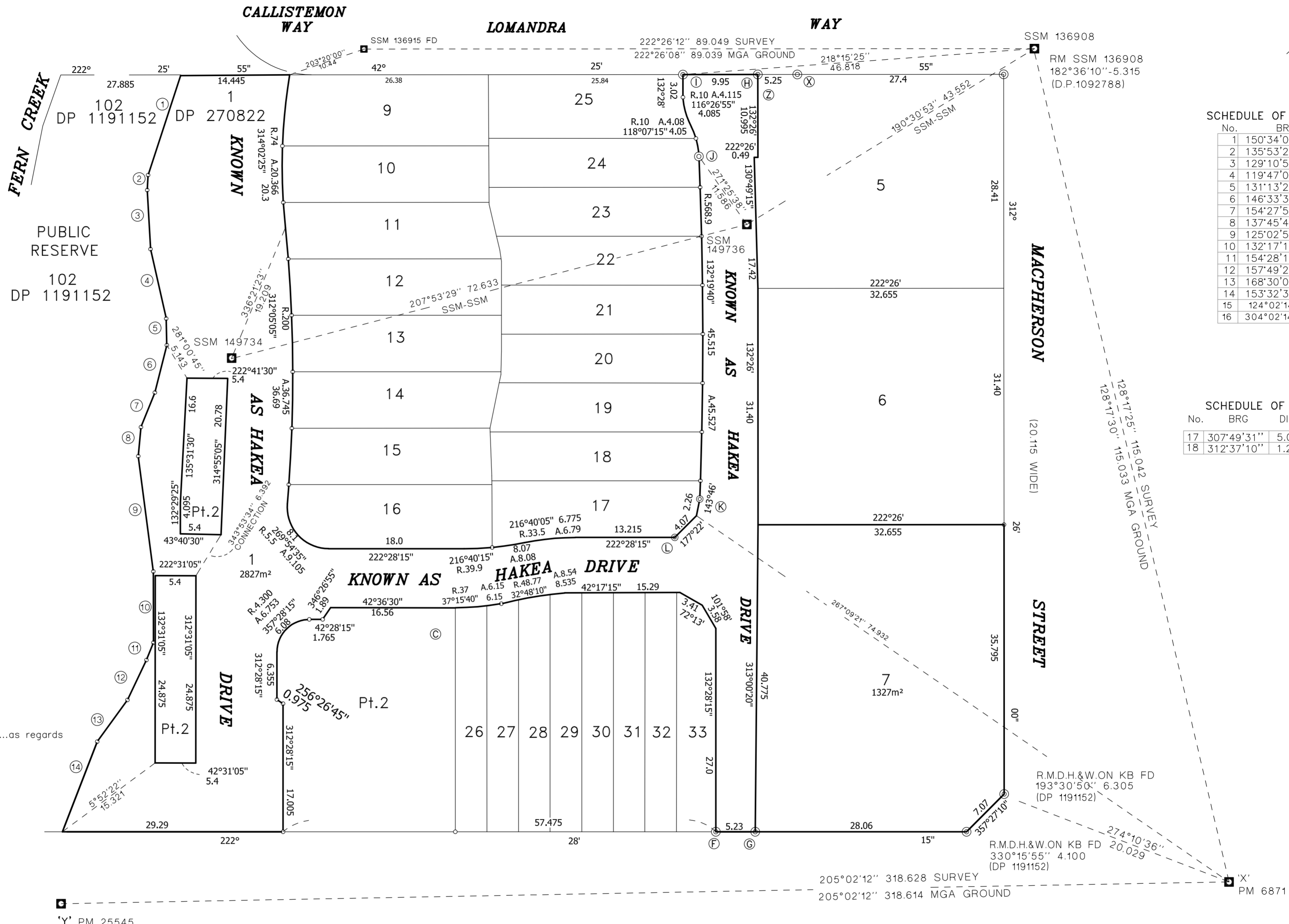

1 AND 7 IN DP 270822

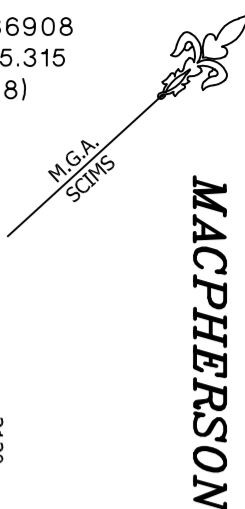

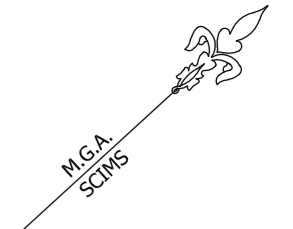
