Dear Lachlan,

In reviewing the progress of the above Development Application, we note that all Councils internal referrals have been received. We thank Council for undertaking the assessment of the application in a timely manner.

In this regard, we note that Council Waste assessment was not supportive due to the following:

- The waste management plan and architectural plans address fit out waste and provide waste storage within the retail entity.
- However, this does not address how waste will be collected and from where. Please provide
  details of the building's commercial/retail waste provisions and confirm that there is
  sufficient volume available within the commercial/retail bin storage to accommodate the
  proposed bakery.

In response to these comments, we offer the following:




Figure 1: "Ongoing Internal Garbage Provisions"

- Waste storage plans are provided under separate cover, as part of this submission, indicating existing commercial bin storage location in the Basement as does the extract at Figure 1 overleaf.
- The volume available (Page 2) and the collection methodology are:

The bins are taken from the dedicated rubbish room on Basement 1 via an internal lift to the rear access Lane way and collected by the Council. Following the collection, they are returned to the room. These movements are controlled and managed by the on-site Facilities Manager for the Strata.




Figure 2: "Extract of Plan"
