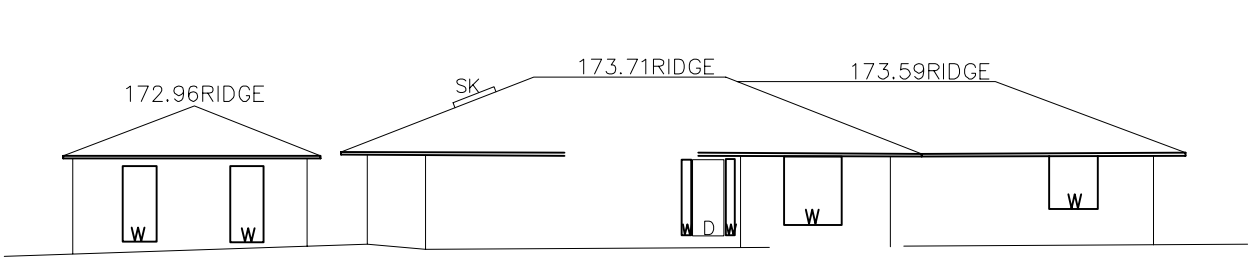

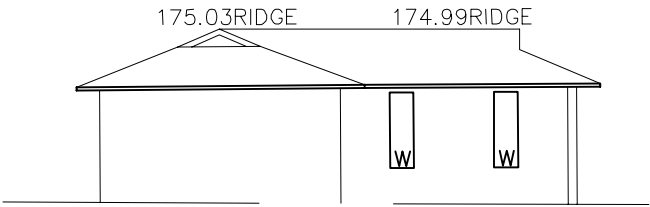

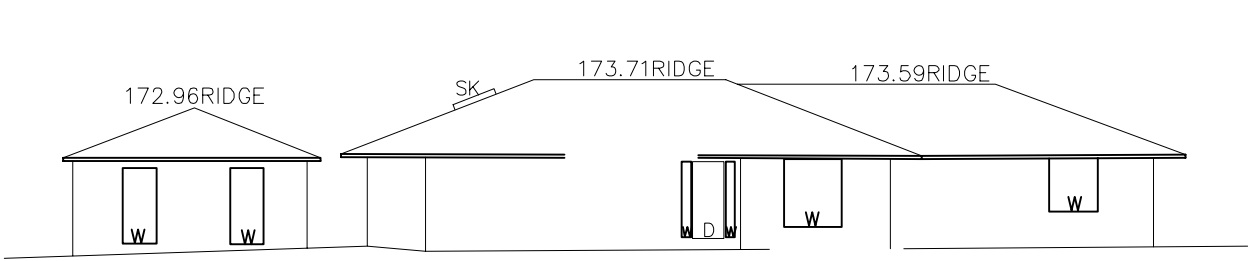
LOT 8 ELEVATION



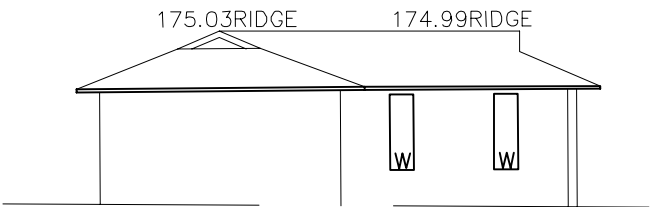
LOT 10 ELEVATION

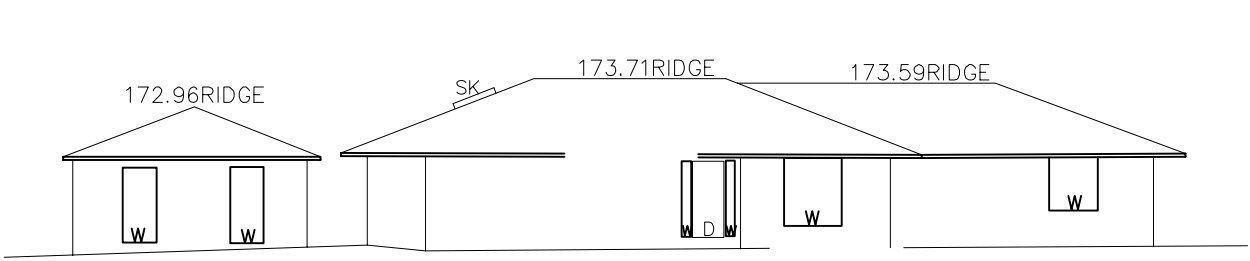

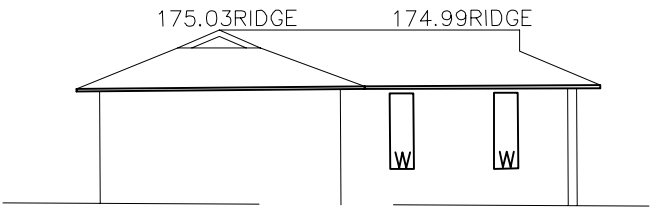
