PROCEEDINGS IN BRIEF

Panel members visited the site and surrounds.

The Panel was addressed by three objectors and representatives of the applicant.

The Panel delayed a decision to allow the applicant to submit amended plans to address the Panel's concerns around cut and fill, and potential privacy impacts as a result of the artificial ground levels close to boundaries.

The applicant has submitted amended plans and the Assessing Officer has prepared a Supplementary Memo recommending approval, along with a number of changes to conditions. The Panel has reviewed the amended plans and Supplementary Memo and is satisfied that the proposal is acceptable.

The Panel concurred with the Officer's Assessment Report, Supplementary Memo and recommendation.

STATEMENT OF REASON

The proposal generally satisfies the relevant strategy, objectives and provisions of Warringah LEP 2011 and the Warringah DCP 2011 subject to conditions.
