While the submission makes reference to other properties along Ocean Road and particularly, references to heights, it does NOT make any reference to the impact on surrounding views from the proposed works.

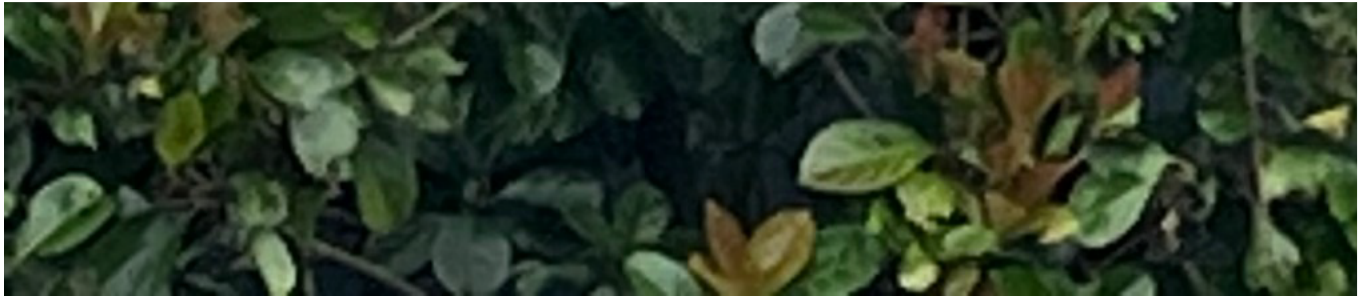
Unlike many of the comparisons whom have no impact to surrounding property views (as they are below cliff fronts), **this submission has significance impact to the view of many properties.**
