1. Summary

This report outlines the outcomes of community and stakeholder engagement conducted from 24 March 2022 to 4 May 2022 as part of Stage 1 of the proposed Frenchs Forest Town Centre Park Upgrades project.

The feedback collected during consultation primarily indicated strong support for the concept plans for each park. The concepts received very high levels of support across the board. The volume of support without any changes was high for each park. The volume of responses of support with changes was quite low much. Respondents who were either neutral or did not support the concepts was very low at less than 10% of total respondents.

Respondents who commented in support of the plans indicated that the proposed embellishments to the parks were welcomed, with each of them being highly underutilised and in some cases fallen into disrepair. Comments reflected that the community was strongly in support of the natural aspects of the designs, while also being family friendly and catering to all ages.

Respondents who suggested changes generally indicated that facilities such as play equipment and basketball courts should be provided and/ or are made larger than proposed to cater to the families within the area.

Respondents who commented against the plans generally indicated concern around removal of natural areas to provide infrastructure along with an increase in mosquito activity around wetland and water outlet areas. Comments also reflected on open areas being preferred for recreational activities and that older children also need to be catered for.


1.1. Key outcomes

The total number of visits to the Your Say Frenchs Forest Town Centre Park Upgrades landing page was 3,261 and the number of visitors was 2,734.

A total of 242 comments were received across the three Your Say pages created for each reserve, and eight via email. This number includes five emailed comments in support/against and three additional emailed comments in relation to general Frenchs Forest Town Centre and suburb upgrades, including roadways which are outside the scope of this engagement.




Brick Pit Reserve








Akora Reserve








Rabbett Reserve

2. Background

This report outlines the community and stakeholder engagement conducted from 24 March 2022 to 4 May 2022 as part of the proposed Frenchs Forest Town Centre Park Upgrades project.

Community engagement on the project is in two stages:

 Stage 1: to understand community sentiment and obtain feedback on the initial concept designs of each park; and



 Stage 2: to understand community sentiment and obtain feedback on the detailed designs for each park, review environment factors studies (where applicable) and to ensure the designs are acceptable to the community before proceeding to construction.

The delivery of the park upgrades from detailed design to construction will follow a staggered schedule. Community consultation on the detailed designs will be at approximately three-quarters complete to allow adequate time for consultation and revision prior to construction. The phasing of the delivery of each park runs from July 2022 until December 2024. Details of the delivery phasing for each park will be available on the Your Say page.

Frenchs Forest was declared a Planned Precinct by the NSW Department of Planning, Industry and Environment on 1 June 2017. The Planned Precinct implements Phase 1 of Council's adopted Hospital Precinct Structure Plan. To provide for the future space needs of this precinct, Council intends to embellish existing open space areas ensuring recreational opportunities are provided to meet community need resulting from the increased population, with a focus on multiple use and enhanced linkages.

Council has received grant funding from the NSW Government Department of Planning and Environment (DPE) to upgrade three parks as part of the Frenchs Forest Town Centre. Concept designs were developed during the Hospital Precinct Structure Plan to give the community an idea of what might be possible at each location.

During the community and stakeholder engagement, input was sought from the community regarding the prepared concepts (stage 1) with feedback obtained being used to refine the concepts and feed the detailed design process (stage 2).

3. Engagement objectives

Community and stakeholder engagement aimed to:

- Objective 1: build community and stakeholder awareness of participation activities (inform)
- Objective 2: provide accessible information so community and stakeholders can participate in a meaningful way (inform)
- Objective 3: identify community and stakeholder concerns, local knowledge and values (consult)

4. Engagement approach

Community and stakeholder engagement for the Frenchs Forest Town Centre Park Upgrades project was conducted between 24 March 2022 and 4 May 2022 and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Matrix (2017).

A project page was established on our have your say platform with information provided in an accessible and easy to read format.

The project was primarily promoted through our regular email newsletter (EDM) channels.

We also utilised site signage at each park, providing QR codes which took the community to the Your Say page for further information and to allow them to make comments on the concept plans.



A notification letter was posted out to 687 residents/properties and the same letter was emailed to 1875 residents who have provided their details to Council for the purposes of Council proposal and Your Say projects.

Feedback was captured through an online comment form embedded onto the have your say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

Email and written comments were also invited.

4.1. Reaching diverse audiences

A thorough stakeholder mapping exercised was completed to identify and understand the needs of the whole community.

It was determined for this project that it was particularly important to hear from resident associations, young families, and youth within the area.

5. Findings

The consultation process attracted a diverse range of responses which supported the need for improved open space within the Frenchs Forest community.

Respondents said they valued the area for its natural areas, local fauna and flora, family friendly atmosphere and various passive and active recreational opportunities.

Overall, there was general support for the proposed upgrades to the three parks, with the majority of respondents supporting the activation of somewhat underutilised spaces. Many felt that the proposed embellishments would be a significant improvement to the area, specifically for active recreation for young people through to providing greater opportunities to explore the natural aspects of the parks. Some expressed that the designs were aesthetically pleasing and had a good balance of preservation of natural areas and activation of recreational spaces.

- This is a great concept to revitalise this reserve and make it a useable and enjoyable space for the community. I fully support this concept.
- It will be great to see this piece of wasteland utilised in this way. I know families who
 like to take their young children "on adventures" and this would certainly provide that
 opportunity.
- The concepts appear to be considerate of the natural environment, something we are very protective of up here in 'The Forest'. Well done Northern Beaches Council keep them coming!
- This looks well thought out and a good mix of facilities, with attention to the natural beauty of native bushland, despite the small area.



While overall supportive of the proposal, many people provided suggestions for how Council should move forward. These included suggestions about larger playground areas, more active recreation areas such as basketball courts, material choices and dog access to the parks.

- I think the childrens playground should be bigger, with a section dedicated to water play as we often have to travel out of area to access this.
- It looks good but I think it's important to have a dog friendly area, or enclosed area for them away from the children's playground.
- Overall I am very excited about this concept, but ideally I'd like to see two basketball half courts incorporated into the space, the removal of the herb garden and the incorporation of possum boxes in the tree canopy to support our local wildlife.
- Please do keep the bike track even better if it's enhanced. The mountain bike tracks
 parallel to Bantry Bay Rd have, and do, provide many of the kids in the neighbour
 plenty of fun without being pressured out of Manly Dam by adult riders. This includes
 the jumps at Brick Pit.
- Can you make a nice kids playground there and also a dog walking area please. We have been going there as live next door. Heaps of water dragons around there.

Some respondents felt that the parks should be left alone and kept natural and did not support the proposal. Others worried about the new boardwalk and viewing platforms at Rabbett and Brick Pit Reserve, bringing more people to the area, and an influx of mosquitos from the improved wetland areas, along with impacts on local wildlife and loss of native vegetation.

Issues and suggestions are further outlined in table 2 below along with Council's responses.

Other concerns

The man-made pond may require further excavation with the removal of soil and vegetation within the Reserve.

The pond structure will provide a landscape feature and viewing platforms but would displace an area that could be used to restore indigenous forest and provide a walking trail.

The area allocated for the pond could be used to re-generate indigenous vegetation, which includes the endangered Duffys Forest Ecological Community.

The pond will be a central feature of the site but without the amenity of shade that trees provide.

INDIGENOUS VEGETATION

Biodiversity Corridor

- A positive aspect of the Concept Plan is the proposal to rehabilitate and enhance indigenous vegetation.
- The indigenous vegetation includes the endangered Duffys Forest Ecological Community...
- The revegetation and regeneration of this ecological community would contribute to its recovery.
- It would also protect and enhance the bushland along Wakehurst Parkway as a biodiversity corridor.

Section 5.2 in the Green Plan states "The plan recognises the bushland along Wakehurst Parkway as a biodiversity corridor which requires protection and enhancement".

Concerns re bushland and forest vegetation:

- The biodiversity corridor will require protection from informal access and high intensity use.
- The bushland area will be fragmented for infrastructure and multiple pathways.
- The man-made pond will remove soil and vegetation within the bushland corridor.
- The man-made pond will remove trees and shade that are attributes of the indigenous forest.

RECREATION

A limited area for passive and active recreation is appropriate.

This includes:

- A walking trail.
- A passive space with shade and seating.
- An active space for playground and outdoor gym.

Brick Pit Reserve has limited scope for recreation due to its small size, location and function as a biodiversity corridor.

HISTORY

Frenchs Forest site history.

- Acknowledge the natural heritage and history of Brick Pit Reserve.
- Describe the tall native forest growing in Frenchs Forest on ridge-top areas with lateritic soils.
- Provide written information and photos.



Brick Pt Reserve Feedback

I have resided at for 13 years now. When we purchased this property, it felt like we were cut into the natural bushland that surrounded us on the East and North sides. We felt like we were living in the Blue Mountains with natural bush views all around us. We couldn't have been happier with the house that is now our home.

Since purchasing the property, we endured the building of the Northern Beaches Hospital and the expansion of the Wakehurst Parkway. The green view on the East side of our property is now gone. We can now see and hear the traffic on the Wakehurst Parkway. The quality of living we enjoyed has diminished significantly, but we accepted it as there was nothing, we could do about it.

This latest proposed change imposed on me and my family is more than I can bear. I have drawn a red square around where my property sits in the picture below. On the North side is our outdoor area and in the North East corner is where we have our spa. If these plans go through as drawn, I will no longer enjoy any privacy at all and I will have increased foot traffic right on top of my home. I can't think of anything worse than sitting in my spa while people are walking past staring at me. We will no longer be able to use my outdoor area without members of the public being able to see us.

I could understand and live with this if I had purchased the house, and this was already here. But there was no way for me and my family to know that this is what would happen to us all these years later.

I don't want to seem unreasonable as I do want to see the land used in a way that all the community can enjoy. As I hope you can appreciate — I just don't want it to be at the expense of me and my family's privacy. My daughter's bedroom window is facing North and I don't want her to live with her curtains always closed to avoid people looking into her room.

I respectfully request that the Council consider leaving the existing land between the back of my property and the Wakehurst Parkway as is. If anything, I would like to see a plan to regenerate the natural vegetation in this area, so I no longer see or hear the traffic from the Wakehurst Parkway.

I further request that if there us a desire to have a "wetland" that there be a bigger break between the North side of my property and where the wetland begins.

I have placed a red rectangle in the pic to the left as an example (IMAGE REMOVED TO PROTECT PRIVACY). This break will ensure that my family's privacy is maintained.

Also, having a wetland so close to my home will bring more mosquitoes and make using my outdoor area less enjoyable.

As a complete alternative to the Wetland concept, can I suggest you build an enclosed off lead dog park instead, like the Frenchs Forest Show Ground next to Lionel Watts Reserve. Again, as long as there is an adequate break between my property and the dog park (natural vegetation to maintain my privacy) I would have no concerns.

If there is a strong desire from within the community that these plans go ahead as is, I know that I am the only property owner that is negatively impacted. With that in mind I respectfully request additional vegetation be planted to create a natural gap between the new picnic area, the lower viewing deck and my home (as shown in with the red rectangles on the pic to the left) (IMAGE REMOVED TO PROTECT PRIVACY). Preferably some sort of hedging to deter people walking up to and congregating on my fence line.



As a third and final alternative to maintain my privacy with minimal changes to this proposal, I request that I be given the opportunity to purchase small amount of land of the East side of my property. This would give me the ability to extend the fence line on the side and side and side of the property. I can then build 6-foot-high brick walls which will then block all views into my home and maintain our privacy.

Note that there is a steep decline off the corner of my property, which is why the read area I am proposing to purchase in the pic is not rectangular in shape. I would not be able to build a wall over this decline. (IMAGE REMOVED TO PROTECT PRIVACY)
