#### 1. Summary

This report outlines the outcomes of community engagement as part of a proposal to reinstate the local playground at Fielding Reserve, Collaroy.

The feedback collected during consultation indicated a high level of support for the proposal, with some comments proposing additional or alternative facilities.

The minority of respondents who were not supportive of the proposal raised concerns that there is no need for the playground as there is a large playground nearby at Collaroy Beach and others suggesting it may contribute to anti-social behaviour, noise and parking issues in the street.



## 2. Background

In 2022 Council adopted the <u>Lets Play! Open Space and Outdoor Recreation Strategy</u>. This strategy set out key directions, priorities and actions outlining how we will manage our open spaces and outdoor recreational facilities over the next 15 years.

Following the analysis of playground distribution within the Northern Beaches, an action was included in the strategy to provide an additional local playground in Fielding Reserve, Collaroy.

The proposed playground is designated as a "Local Playground" so will be small scale, and is likely to include a swing set and one or two other play pieces or site furniture.

## 3. Engagement objectives

Community and stakeholder engagement aimed to:

build community and stakeholder awareness of participation activities

- provide accessible information so community and stakeholders can participate in a meaningful way
- provide balanced and objective information to assist in understanding the problem, alternatives and/or solutions
- identify community and stakeholder concerns, local knowledge and values.

### 4. Engagement approach

Community and stakeholder engagement for the playground proposal at Fielding Reserve, Collaroy was conducted between 1 May 2023 to 28 May 2023, and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Strategy (2022).

A project page was established on our have your say platform with information provided in an accessible and easy to read format.

The project was primarily promoted through our regular email newsletter (EDM) channels.

Feedback was captured through an online comment form embedded onto the have your say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

As well as the sentiment question and free text, a rating tool was used to ask participants to rate the importance of the following elements of play:

- swings
- moving play pieces
- climbing pieces
- imaginative play
- toddler aged play (1-4)
- junior aged play (3-6)
- senior aged play (6+)
- seating
- tree planting
- other (including text field)

Email and written comments were also invited.



## 5. Findings

Feedback received during the engagement period was mostly positive towards the proposal with 86% of respondents stating they were supportive of the proposed local playground by selecting that they either supported the proposal or supported the proposal with changes.

Amongst the comments from respondents there were many requests for other facilities and uses within the reserve such as basketball hoop, bike track, gym equipment and dog park.

A small number of respondents were against the proposal. Some suggesting that there is no need as there is a large playground nearby at Collaroy Beach and others suggesting it may contribute to anti-social behaviour, noise and parking issues in the street.

The features that were rated as most important included climbing pieces, swings and seating.

Project Support	Most submissions expressed support for the project as they see the benefit of a local playground in Fielding Street.	We acknowledge that many respondents have been compelled to inform Council of their support for the project.
Other Facilities	Some respondents used the opportunity to request other facilities such as fitness equipment, basket ball hoop, facilities for teenagers or dog exercise space	We acknowledge that some members of the local community would like other facilities within the reserve either to compliment or as an alternative to the playground.  The playground will only take up a portion of the reserve, hence leaving space for other activities or future facilities.
Play Equipment	Some respondents requested particular types of play equipment that they felt would best suit the playground.	We welcome suggestions for play equipment however the size and budget of the playground is limited in what can be provided. Council will work with a playground supplier to ensure the best possible outcome is achieved.



Theme	Issues, change requests and other considerations raised	Council's response
Anti-social Behaviour	Some respondents felt that the location was not suitable for a playground due to anti-social behaviour in the area and that a playground would attract more anti-social behaviour.	Council's Community Safety Officer has consulted with police regarding the proposal to develop a local playground at Fielding Reserve. Police advised that they are not aware of any issues in the reserve or the area surrounding Fielding Street that should prevent the playground proposal from proceeding. Their review of police data indicates that the level of antisocial behaviour in that area is extremely low, with the only incidents reported recently being domestic related.
		The installation of a playground will further increase the passive surveillance of the area.
		The term passive surveillance refers to the opportunities for people in public spaces and adjoining buildings to casually see into the space e.g. users of an area, passers-by or people in nearby properties and doesn't imply that residents are expected to actively monitor the reserve.
		Passive surveillance increases the perception of being seen, which is known to be a deterrent for antisocial behaviour as it also increases the risk of consequences. The reserve's frontage to the street, the nearby walkway from another street, and the presence of numerous neighbouring residences with windows and driveways adjacent to and facing the reserve all create an impression that you are able to be seen in the reserve.

During the consultation/exhibition. Council received a number of questions either through direct contact or within feedback received.

Question raised in feedback	Council's response
What is your plan for resident parking??	Local playgrounds are located to serve very small catchments where walking is the primary means of transport. Local playgrounds only offer one or two pieces of play equipment and hence generally are not a destination where people travel by cars to get to.
	In the case of Fielding Reserve, due to being surrounded by apartments, there is a large catchment of people who live in very close walking proximity to the park. The park and playground is to offer amenity to these local residents. The park is also connected to surrounding residents by footpaths. The playground is intended to be very low key and hence would not be a destination where people would consider driving to.
Will dogs still be able to use this space if a children's playground is built on the area?	Dogs are currently allowed to use the Fielding Reserve if kept on a lead. It is NSW Law under the Local Government Act 1993 that dogs are not permitted within 10m of a playground.
Also what's the likelihood of Hall Reserve being fenced off for small dogs in the neighbourhood to play safely?	The proposal for Fielding Reserve is to locate the playground at the street end of the reserve, hence there would be space at the rear of the reserve to allow recreation for dogs on a lead.
	Please note that both Fielding and Halls Reserves are not a designated off leash dog areas. Consideration of Halls Reserve to be fenced or designated as an off leash dog area is out of scope for this project.
Currently it's a dog area, with more kids in the area will this remain the same?	The proposal for Fielding Reserve is to locate the playground at the street end of the reserve, hence there would be space at the rear of the reserve to allow recreation for dogs on a lead.
In regards to the playground in fielding street, will my rates go up.	The playground proposal will not have any impact on rates.
Will it be patrolled at night for improper activity.	Council does not conduct night patrols on playgrounds. Council conducts regular maintenance checks on playgrounds during normal working hours. Residents should contact NSW Police if they suspect improper activity at any playground.
Why a playground is needed less than 5 minutes walk from a large playground at Collaroy Beach	When undertaking consultation for the more recent 2023 Let's Play! Open Space and Recreation Strategy and Action Plan Council received requests to reinstate the playground that was removed in 2013. It was considered that people value small local playgrounds as a more intimate spaces closer to home. Crossing a major road to use a large



	regional playground is a different experience that is not always suitable.
Whether there will still be space for families to play ball sports and use the field for other uses. Right now there is a huge lack of open green space in the area to safely kick a football with family (which many people do at this reserve) for example.	The proposal for Fielding Reserve is to locate the playground at the street end of the reserve, hence there would be space at the rear of the reserve to allow for ball sports and other recreational uses.
Whether dog owners will still be allowed to walk their pet on a leash at the park	The proposal for Fielding Reserve is to locate the playground at the street end of the reserve, hence there would be space at the rear of the reserve to allow recreation for dogs on a lead.
Whether the proposed plans would further exacerbate flooding and drainage issues at the park.	The playground would consist of permeable surfaces and hence would not exacerbate flooding and drainage issues.
If the playground is to go ahead, why not place it further back the reserve, away from the road where it would be safer for families?	The proposal for Fielding Reserve is to locate the playground at the street end of the reserve to allow for greater passive surveillance to and from the playground.
Could Council please have a look at replacing the steps and the path with a low grade ramp? Also at the top of the steps leading to The Avenue there is less than a metre of space to the busy road which allows parking right where a child needs to cross the road. The elimination of just one parking spot here would make their passage much safer.	This request is out of scope of the playground project, however the request has been forwarded to the responsible Council department for consideration.
Any chance of a basketball court surrounded by high fencing being placed there too for older kids?	It is unlikely a basketball facility would be considered for this location. Generally, basketball facilities are located further from residential properties as the constant bouncing of the ball can generate noise complaints in a close built up environment.

We highly approve of Council's intention to reinstate this little unloved park. We live in The Avenue, close to the park, and know that there are many children in our street who will love the new facility. Access to Fielding St for them is a descent down a flight of 8 steep steps and along a flat path about 30 metres long to the cul de sac in front of the park, which would be unmanageable for a mother with a stroller. Could Council please have a look at replacing the steps and the path with a low grade ramp? Also at the top of the steps leading to The Avenue there is less than a metre of space to the busy road which allows parking right where a child needs to cross the road. The elimination of just one parking spot here would make their passage much safer. This little park is surrounded by trees, making it a very pleasant space, however there are a couple of small trees in the park which may be a climbing hazzard, especially for boys, and the Council might consider removing these.
