PROPOSED DEVELOPMENT IN DETAIL

This Section 4.55(2) Modification Application seeks retrospective consent to amend the approved DA2020/0128:

- To extend retaining wall along north-western boundary by 3.5m.

The works have already commenced and this application is for the retrospective approval of the works.

The site has a surveyed area of 594.4m².</p> <p>The site is located within the E4 Environmental Living zone and accommodates a single dwelling house.</p> <p>The site has a cross fall from the northeast to southwest (i.e. front to rear) of approximately 6.1m.</p> <p>The site has vegetation both within the front and rear yard, comprising of medium to large shrubbery and trees.</p> <p>Detailed Description of Adjoining/Surrounding Development</p> <p>Adjoining and surrounding development is characterised by single and two-storey dwelling houses with a variation of architectural designs.</p>

In this regard it is considered that the site poses no risk of contamination and therefore, no further consideration is required under Clause 7 (1) (b) and (c) of SEPP 55 and the land is considered to be suitable for the residential land use.
