- LEGEND**

**CONCEPT DESIGN FEATURES**

- ① Existing vehicle turn-around area to be retained
- ② Existing concrete threshold area to be retained
- ③ Accessible parking spaces to be retained in their current location
- ④ Extend shared zone linemarking
- ⑤ Existing parking pay-station retained
- ⑥ Reconstruct existing pathway/ramp to meet new levels (maintain the existing alignment)
- ⑦ Coloured concrete accessible ramps (1:14 & 1:20 grades)
- ⑧ New engineered retaining wall to tie into existing carpark retaining wall (extent TBC)
- ⑨ Existing retaining walls to be retained
- ⑩ Proposed native feature planting
- ⑪ Sandstone retaining edges (250mm high)
- ⑫ Existing lawn, sandstone logs & sewer infrastructure to be retained and protected
- ⑬ Small stair to tie into existing levels
- ⑭ New widened entry to the swim club with the opportunity for seating
- ⑮ Retain existing coloured concrete pathway/ramp (& sandstone logs/edging) tying into existing upper levels
- ⑯ Existing stair access to rockpool
- ⑰ New stairs to connect to existing stairs and landings (make good concrete and handrails as necessary)

**CONCEPT DESIGN FEATURES**

- ① Proposed FRP boardwalk 1.8m wide providing safe, separated, accessible pedestrian access along the extent of the carpark
- ② Reconfigure parking to allow for new pathway connection. No loss of parking spaces
- ③ Embellish existing native shrub and groundcover planting
- ④ Low sandstone block wall to enable greater vehicular maneuverability space
- ⑤ Coloured concrete path extension to tie into existing levels allowing for a continuous accessible connection to Fishermans Walk
- ⑥ Retain existing entry features to Fishermans Walk
