

We have undertaken a review of the amended architectural plans submitted in support of the Section 4.55 Modification Application for the above project. This review considered the proposed modifications against the requirements of the Building Code of Australia (NCC 2022), the Disability Discrimination Act 1992 (DDA), and applicable Accessibility Standards, including the Disability (Access to Premises – Buildings) Standards 2010 and AS 1428 series.

We have accessed and reviewed the revised architectural drawings and associated documentation lodged with this modification application. The review was undertaken to confirm that the proposed changes do not adversely impact the project's capability to achieve compliance with the BCA and relevant accessibility requirements.

In conclusion, the proposed modifications do not present any significant compliance issues. We confirm that the amended design remains capable of satisfying all relevant provisions of the BCA, DDA, and accessibility standards, and no impediments to approval are anticipated at Construction Certificate or Occupation Certificate stages as a result of these changes.
