

### Ref; Construction of New Jetty extension, ramp, pontoon rebuild and mooring piles at the above address.

Thank you for your invitation to provide this submission. I have pleasure in offering the following quotation to construct the above referenced facility specified as follows;

#### Scope of works

- . Establish on site with required materials on rig.
- . Remove existing ramp and pontoon.
- . Remove existing pontoon support piles.
- . Install new jetty support piles and construct new jetty extension 5.5 meters approx. x 1.2 meters.
- . Supply and install two new pontoon support piles and new berthing pile 250 toe, dress and crown.
- . Construct and install new hardwood ramp 6 meters x 1.2 meters with heavy duty hot dipped galvanised hinge brackets.
- . Construct and install new Kiln dried hardwood deck pontoon 3.6 meters x 2.4 meters complete with large rubber fender to 3 sides and heavy duty horn cleats, using existing pods.
- . Remove all site generated waste.

Monies to be paid as per schedule below.

Terms of payment thereafter shall be 7 (seven) days from date of invoice. Amounts outstanding after this period will attract interest at the rate of 2% per day on the outstanding amount.

Ownership of all goods and materials on site shall remain vested in Estuary until full payment has been received.
