- All erosion and sediment control measures, including revegetation and storage of soil and topsoil, shall be implemented to the standard of the Soil Conservation of NSW.

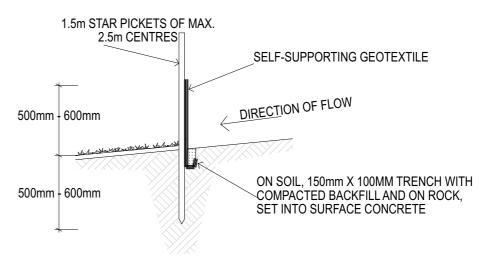
