Background

Development Consent Mod2023/0396 was granted by Council on 19 September 2023 for Modification of Development Consent DA2022/1929;

Details of Modification Application

Under Section 4.55(1) of the EPA Act 1979, a consent containing an error or mis-description may be amended. The Northern Beaches Community Participation Plan does not require the notification of Section 4.55(1) modification applications as they are considered to be of minimal environmental impact.

The application seeks to correct various mis-descriptions and incorrect references to the approved development consent, as below. The corrected wording/descriptions are indicated in *italics*.

- 1. Mod2023/0396 was incorrectly described as "Modification of Development Consent DA2022/1929 granted for Alterations and additions to a dwelling house."
 - The correct description of Mod2023/0396 is "Modification of Development Consent DA2021/2393 granted for Construction of a dwelling house including a swimming pool."
- 2. The Modification Summary Table included in the Notice of Determination for Mod2023/0396 read as follows:
