#### **Background**

The abovementioned development consent was granted by Council on 2 July for use of part of the premises as a dwelling house;

#### **Details of Modification Application**

Under Section 96(1) of the EPA Act 1979, a consent containing an error or mis-description may be amended. Warringah DCP (A7 Notification) does not require the notification of Section 96(1) modification applications as they are considered to be for minor changes that do not affect the development or the amenity of adjoining properties.

The application seeks to modify condition(s) No. 1, - Approved Plans and Supporting Documentation. In the list of Stamped Plans, several plans reference the wrong Revision number. This Section 4.55(1) application seeks to amend the revision number to align with the Stamped Plans.

### Consideration of error or mis-description

An earlier vision of the architectural plans was incorrectly referenced in the Approved Stamped Plans list in Condition 1 and requires rectification.

#### Conclusion

It is considered that the modification is minor in nature and consistent with the provisions of section 4.55(1) of the EPA Act 1979 and is therefore recommended for approval.

#### Recommendation

THAT Council as the consent authority approve Modification Application No. Mod2018/0422 for Modification of Development Consent DA2018/0820 granted for use of part of the premises as a dwelling house on land at Lot 1 DP 813670,12 Lockwood Avenue, FRENCHS FOREST, as follows:

Add Condition No.1A - Modification of Consent - Approved Plans and supporting Documentation to read as follows:
