The proposed development comprises the internal alterations and additions to the existing Building F, Units 17 and 18 within the Crest Industrial and Business Estate at 100 Meatworks Avenue, Oxford Falls. The proposal is limited to the interior of the building and does not proposal any alterations to any existing external building elements.

All proposed works will be undertaken by suitably qualified contractors and all waste will be removed by a qualified contractor to the appropriate recycling outlet or licensed waste facility as required.

DEMOLITION AND CONSTRUCTION WASTE MANAGEMENT

There is sufficient space within the building on-site to ensure all waste and recyclable materials generated during demolition and construction can be stored on-site and will not disrupt or impact the access or operation of any adjoining property.

During the demolition and construction phase of the development, a total of eight (six tonne) skip bins will be located in the internal loading area of Unit 17. The location of the skip bins is shown in **Attachment A**.


