## **Addition Comments:**

Reference is made to the proposed works under the State Environmental Planning Policy (Infrastructure) 2007 include the installation of a new access driveway and footpath located along the western boundary (Rose Avenue frontage). In addition, as part of the above works, repairs to the existing concrete crib retaining wall are proposed.

Tree No. s 1- 17 are located in the area required for the above proposed works and structures Land. Many of the large Eucalyptus trees are in poor health and condition due to a poor growing environment and several are considered structurally unsound. Tree removal is subject to replanting.

It was also noted during the inspection that a Eucalyptus punctata (Grey Gum) located adjacent to Tree1 (Rose Avenue frontage) requires a further inspection due to the presence of fruiting bodies sighted on the trunck.
