The Growing My Way Tree Consultants practice (from herein GMW) as the retained Project Arborist was recently again secured to provide documentation linked to the yet to be determined Section 4.55 Modification to Development Consent (Mod2025/0211) lodged with the Northern Beaches Council (from herein the NBC).

The proposed modifications are linked to changes within only the front yard of the subject site.

By our interpretation (including an onsite inspection of Saturday, 10 May 2025 in the presence of the builder (TM Construction - Todd Maunder) the plans recently provided (Issue. H, drawings numbered L-00 through to L-16, dated 18 March 2025) were reviewed onsite. See Attachment B drawings, L-05 (Planting Plan), L-10 (Section E – Carport), L-11 (Elevation F – carport, L-12 (Elevation G Carport), L-13 (Elevation H Carport) & L-14 (Elevation I Street Elevation).

By our interpretation, relative to Tree Management (DA determination 'Conditions of Consent' (DA2023/0827 – see next page list of conditions that apply) there is no need to modify the as originally specified 'Tree Management' provisions within the proposed to be modified DA determination. Fundamentally, the changes proposed are linked to a revised ground level/carport & a reconfigured mostly suspended 'boardwalk pathway' linking the road reserve to the main entry to dwelling.

'Tree Protection' (as per the original DA determination) is confirmed as continuing to be compliant with the relevant DA determination 'Conditions of Consent, see page below).

On the basis, no change is proposed relative to 'Tree Management' by the Section 4.55 Mod. 2025/0211the below DA determination 'Conditions of Consent' (relative to Tree/Vegetation Management) are presumed to remain the same:
