The request to modify the above-mentioned Development Consent has been approved as follows:

A. Modify Condition ANS02 to read as follows:

The hours of operation of the premises (i.e. hours open for business) must not exceed 6:00am to 10:00pm – Monday to Friday and 8:00am to 10:00pm – Saturday and Sunday without the prior consent of Council.

Reason: To ensure amenity of the surrounding locality is maintained and hours of operation are consistent with those in surrounding locality.

B. Add Condition 16 to read as follows:

The use of amplified noise sources that may be audible in nearby dwellings is prohibited before 8:00am and after 6:00pm.

Reason: To ensure amenity of the surrounding locality is maintained.

Important Information

This letter should therefore be read in conjunction with DA153/2016 dated 17 August 2016.

Please note that on site works cannot proceed unless a Construction Certificate application for the modified proposal has been lodged with and approved by Council or an accredited certifier, and relevant conditions of the Development Application have been carried out.
