

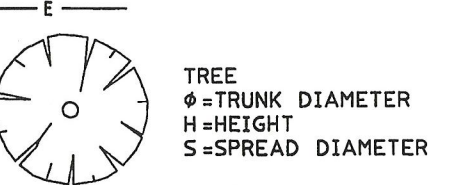


NOTES
