Background

The abovementioned development consent was granted by Council on 5 December 2023 for alterations and additions to a dwelling house.

Details of Modification Application

Under Section 4.55(1) of the EPA Act 1979, a consent containing an error or mis-description may be amended. The Northern Beaches Community Participation Plan does not require the notification of Section 4.55(1) modification applications as they are considered to be of minimal environmental impact.

The application seeks to modify condition(s) No. 8, which reads as follows:

8. The applicant is to lodge a bond with Council for the following:

Drainage Works

As security against any damage or failure to complete the construction of stormwater drainage works required as part of this consent a bond of \$50,000.

Details confirming payment of the bond(s) are to be submitted to the Principal Certifier prior to the issue of the Construction Certificate.

Reason: Protection of Council's infrastructure.

Consideration of error or mis-description

Council's Development Engineering department has reviewed the modification and confirms that the proposal does not pose a significant risk to Council's stormwater asset. In this regard, condition No. 8 is recommended to be amended accordingly.
