
SITE DESCRIPTION

Detailed Site Description:	The subject site consists of one (1) allotment located on the northern side of Beaconsfield Street.
	The site is regular in shape with a frontage of 16.96m along Beaconsfield Street and a depth of 43.47m. The site has a surveyed area of 660.7m ² .
	The site is located within the E4 Environmental Living zone and accommodates an existing two storey brick and fibro dwelling house with a metal roof.
	The site contains one large canopy tree within the front yard and a variety 2m-3m palms and shrubs along the eastern and western boundary.
	Detailed Description of Adjoining/Surrounding Development
	Adjoining and surrounding development is characterised by similar one and two storey residential dwelling houses.

State Environmental Planning Policies (SEPPs) and State Regional Environmental Plans (SREPs)

SEPP 55 - Remediation of Land

Clause 7 (1) (a) of SEPP 55 requires the Consent Authority to consider whether land is contaminated. Council records indicate that the subject site has been used for residential purposes for a significant period of time with no prior land uses. In this regard it is considered that the site poses no risk of contamination and therefore, no further consideration is required under Clause 7 (1) (b) and (c) of SEPP 55 and the land is considered to be suitable for the residential land use.

SEPP (Infrastructure) 2007

Clause 45 of the SEPP requires the Consent Authority to consider any development application (or an application for modification of consent) for any development carried out:

- within or immediately adjacent to an easement for electricity purposes (whether or not the electricity infrastructure exists).
- immediately adjacent to an electricity substation.
- within 5.0m of an overhead power line.
- includes installation of a swimming pool any part of which is: within 30m of a structure supporting an overhead electricity transmission line and/or within 5.0m of an overhead electricity power line.

Comment

The proposal was referred to Ausgrid. No response has been received within the 21 day statutory period and therefore, it is assumed that no objections are raised and no conditions are recommended.
