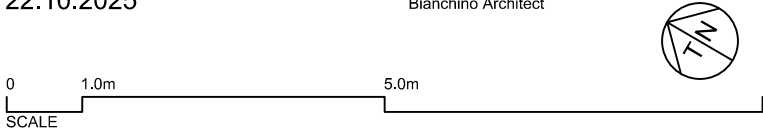


LOWER GROUND FLOOR DIMENSION PLAN

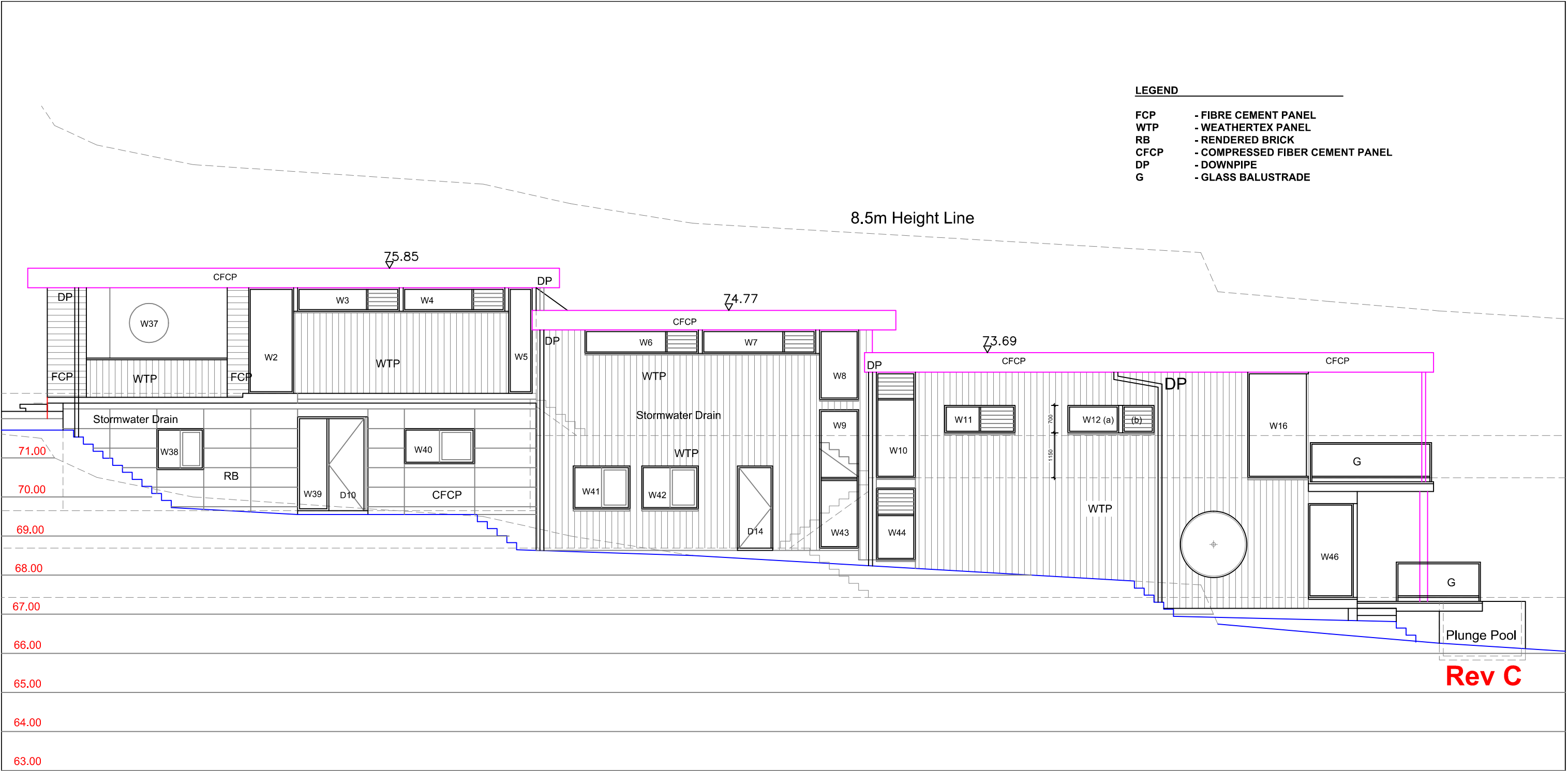

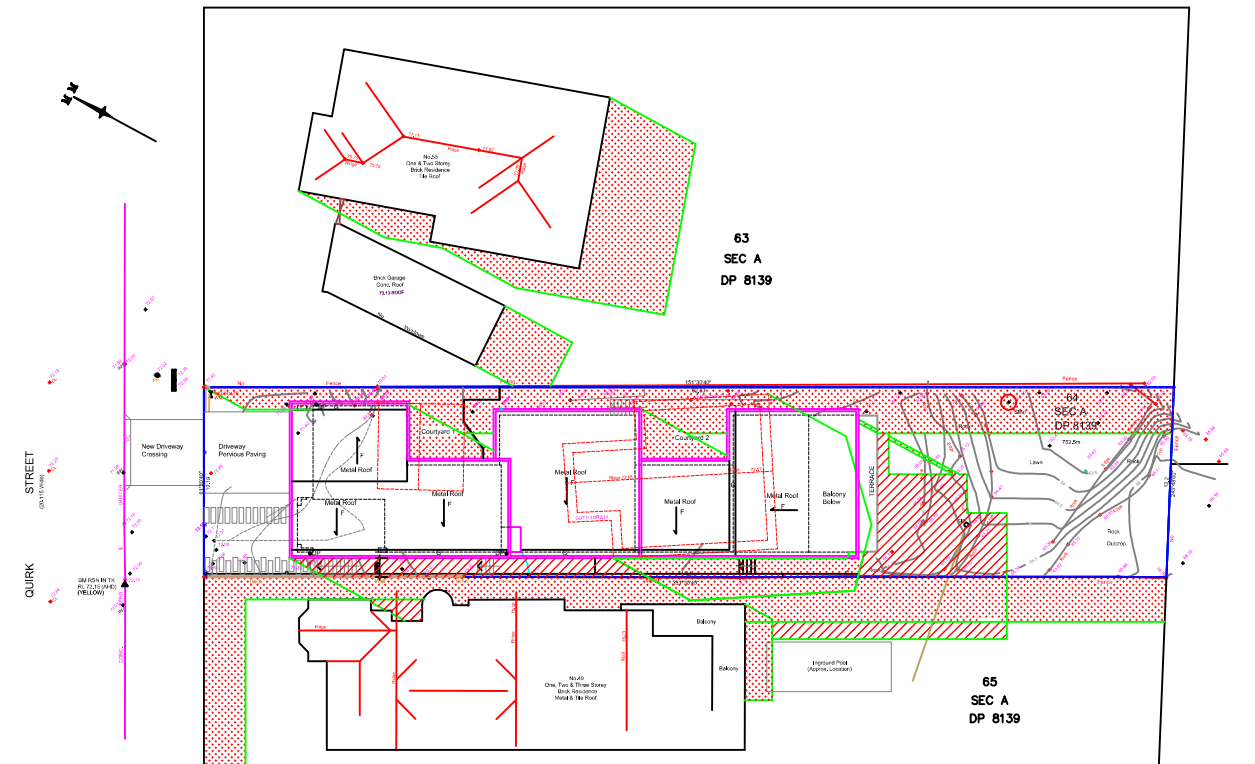


SUN AZIMUTH ANGLES

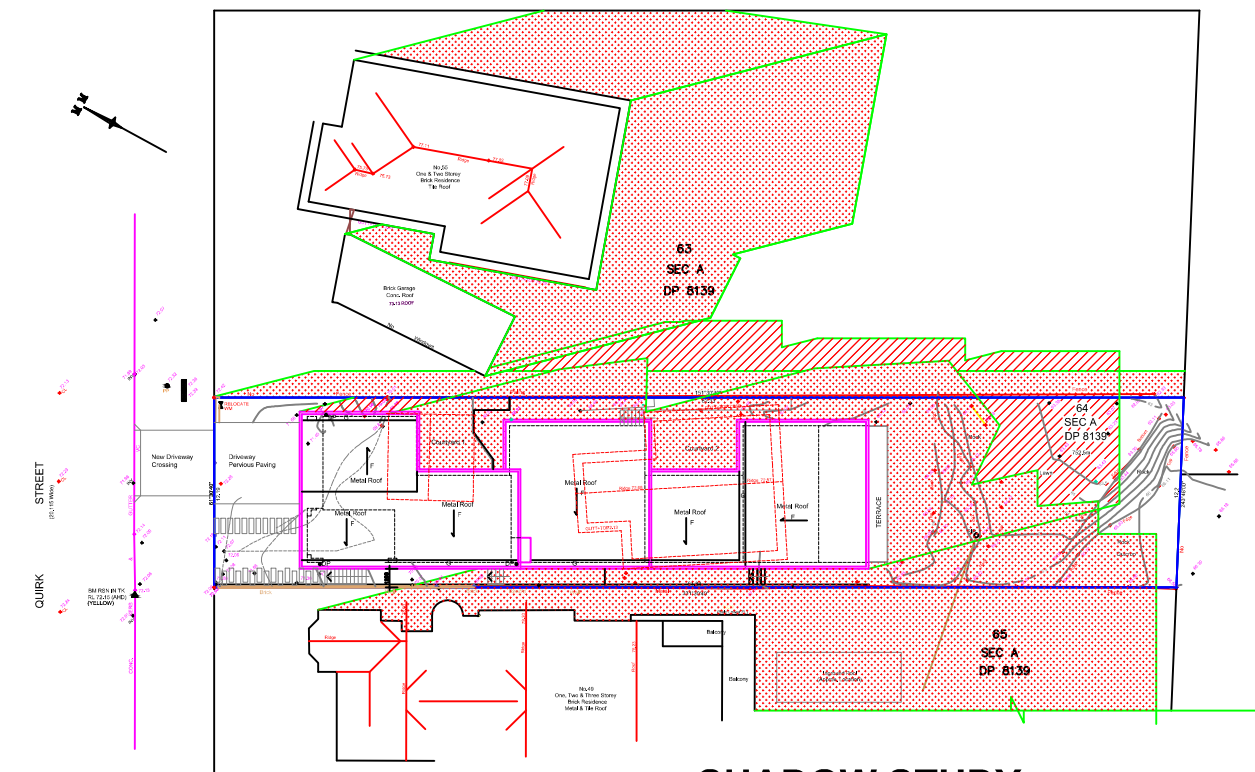
