### **DEVELOPMENT CONSENT OPERATIONAL CONDITIONS**

#### Skin penetration operation

The operation of the skin penetration premises including all associated equipment must comply and be maintained in accordance with the following:

- Division 4 of the Public Health Act 2010,
- Part 4 of the Public Health Regulation 2012,
- Australian Standard AS/NZA 2773:2019 Ultrasonic cleaners for health service organisations,
- Australian Standard AS/NZS 4815:2006 Office-based health care facilities,

Reason: To ensure compliance with relevant legislation to protect public health (DACHPBOC5)

#### **Registered Medical Practitioner**

Treatments and procedures that are prescribed to be performed by a Registered Medical Practitioner must only be performed by a person registered as a medical practitioner under the Australian Health Practitioner Regulation Agency.

Reason: To comply with National Law and protect public health (DACHPBOC6)

# CONDITIONS WHICH MUST BE COMPLIED WITH PRIOR TO THE ISSUE OF THE OCCUPATION CERTIFICATE

#### **Notification of Skin Penetration Business**

The skin penetration premises must notify the local government authority via the approved form prior to occupation certificate being issued.

Reason: Skin penetration premises are required to be registered under the Public Health Regulation 2012 (DACHPFPOC4)

## ON-GOING CONDITIONS THAT MUST BE COMPLIED WITH AT ALL TIMES

#### **Hours of Operation**

The hours of operation are to be restricted to:

Monday - Friday 7:00am to 7:00pm Saturday 8:00am - 4:00pm Sunday and Public Holidays - No operation

Reason: TO ensure noise amenity of the area (DACHPGOG6)

#### **Commercial Waste Collection & Deliveries**

Waste and recyclable material generated by this premises must not be collected between the hours of 5:00pm and 7:00am on any day. Deliveries must not occur between the hours of 5:00pm and 7:00am on any day.

Reason: To protect the noise amenity of the area (DACPLG23)
